### INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On May 1, 2014, historical impacts were discovered during abandonment activities at the Howard 25C-22HZ production facility. The facility was shut in, associated infrastructure removed, and excavation activities were initiated. Groundwater was encountered in the excavation area at approximately 4 feet below ground surface (bgs). The COGCC has issued Spill/Release Point ID 437084 for this release.

Soil samples were collected as described in the Initial Form 27. Based on the data presented, impacted soils in the excavation area were remediated to be in full compliance with State standards.

#### Proposed Groundwater Sampling

- ☒ Will groundwater samples be collected as part of this investigation? ( Number, analyses, and locations of samples ):

Between November 10, 2014 and April 23, 2018, a total of fifteen (15) temporary monitoring wells (BH01 - BH11, BH07R, BH07R2, BH09R, BH10R) were installed to further assess the extent of groundwater impacts. Quarterly groundwater sampling was initiated on November 20, 2014, and is ongoing at the eleven (11) temporary monitoring wells remaining at the site (BH01 - BH06, BH08, BH11, BH07R2, BH09R, BH10R). Wells BH07, BH07R, BH09, and BH10 exhibited dry well conditions and were abandoned following replacement well installation. Groundwater samples are collected from the temporary monitoring wells on a quarterly basis and analyzed for benzene, toluene, ethylbenzene, and total xylenes (BTEX). Groundwater analytical data is presented in Table 1, and the groundwater sample locations are illustrated on Figure 1. Laboratory analytical reports are included as Attachment A.

The 11 temporary groundwater monitoring wells (BH01 - BH06, BH08, BH11, BH07R2, BH09R, BH10R) will continue to be sampled on a quarterly basis and submitted for laboratory analysis of BTEX until concentrations remain in full compliance with State standards for four consecutive quarters. Additional temporary groundwater monitoring wells may be installed, as necessary, to maintain point-of-compliance (POC).

## SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

Between May 1 and 7, 2014, approximately 220 cubic yards of impacted material were excavated and transported to the Front Range Regional Landfill in Erie, Colorado. Approximately 50 barrels of impacted groundwater were removed from the excavation area via vacuum truck and transported to a licensed disposal facility.

## REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Laboratory data indicate that impacted soils in the excavation area have been remediated to be in full compliance with State standards. Quarterly groundwater monitoring is ongoing and will be continued until concentrations remain in full compliance with State standards for four consecutive quarters. Additional remediation measures, including air sparging (AS) and enhanced fluid recovery (EFR), are currently under evaluation to address potential remaining groundwater impacts. Estimated time to attain NFA is TBD based on the groundwater concentrations, the extent of impacted groundwater, and the efficacy of selected remedial technologies.

## GROUNDWATER MONITORING

Between November 10, 2014 and March 28, 2017, a total of 15 temporary groundwater monitoring wells were installed at the site to assess the extent of groundwater impacts. Wells BH07, BH07R, BH09, and BH10 exhibited dry well conditions and were abandoned following the installation of replacement wells BH07R2, BH09R, and BH10R. The 11 remaining temporary monitoring wells (BH01 - BH06, BH08, BH11, BH07R2, BH09R, BH10R) will continue to be sampled on a quarterly basis and submitted for laboratory analysis of BTEX until concentrations remain in full compliance with State standards for four consecutive quarters. Additional temporary groundwater monitoring wells may be installed, as necessary, to maintain POC. Groundwater sample locations and a potentiometric surface contour map for the Second Quarter 2018 are illustrated on Figure 1. Well completion logs for the temporary monitoring wells are included as Attachment B.
