Well location and the offsite tank battery has not meet Rule 1004 standards, as bare patches and weedy, annuals (Kochia) were observed. Also, appears some gravel remains along portions of the access road. Please refer to the attached inspection photos for more detail.

Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including weed management and stormwater erosion. Operator shall submit a Form 4 Final Reclamation Complete notice when the location meets Rule 1004 standards. COGCC may conduct follow-up inspections prior to receiving said notice to ensure compliance with Rule 1004.
