A rise in Bradenhead pressure was logged on 6/30/2018 at approximately 01:15 and was subsequently reported (DOC #401690879). The rise in Bradenhead pressure occurred while frac operations were taking place on the subject well. Currently, an ongoing investigation is being conducted as to the root cause of the Bradenhead pressure event. Kerr-McGee will follow-up with our findings in 30 days. Thank you.
