Operator Comment: 2) Laramie Energy has incorporated this location into our 2018-2023 Drilling Program. To minimize surface disturbance and habitat fragmentation in the highly sensitive Hawxhurst Wildlife Area we intend to make use of this previously disturbed location. For that reason we are requesting an Interim Reclaim Variance to accomodate a limited term of use for the surface. Our intent is to reclaim the locition fully at the end of our drilling program cycle. Best Management Practices (BMPs) are maintained to control storm water runoff in a manner that minimizes erosion, transport of sediment offsite and site degradation. Surface disturbance and fill slopes have been built, stabilized and revegetated in such a way as to minimize erosion to the extent practicable.
