Corrective Action:	<p style="color: blue;">This location is not in compliance with Rule 1004 due to gravel and a culvert remains along the access road and location which has not been re-contoured or re-graded and decompacted to meet the adjacent terrain. Debris is still on location. Well was plugged 6/3/2004 and work should have been completed by 6/3/2005. Plant species encountered included but was not limited to <i>Aristida purpurea</i>, <i>Pascopyrum smithii</i>, <i>Elymus trachycaulu</i>, <i>Sporobolus cryptandrus</i>, <i>Grindelia squarrosa</i>, <i>Heterotheca villosa</i>, <i>Sphaeralcea coccinea</i>, and <i>Gutierrezia sarothrae</i>. Please refer to the attached inspection photos for more detail. Please refer to the attached inspection photos for more detail.</p> <p style="color: red;">Perform reclamation in accordance to Rule 1004. Remove gravel from the access road and location; perform compaction alleviation and re- contour/re-grade. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards. Final reclamation activities shall be complete no later than 9/17/2018 or sooner depending on favorable environmental conditions.</p>	Date 09/17/2018
