Comment: Project area is surrounded by pinyon juniper woodland. Vegetation around the project area is degraded and there is very little desirable vegetation within the interim reclamation area. If vegetation cover is not increasing significantly during the remainder of the 2018 growing season, the revegetation will be required during the fall 2018 seeding window, and no later than November 1, 2018. Cattle exclusion and mulching will likely be needed for successful vegetation establishment.
