**General Comment:**

Site inspection to assess pit remediation and landfarm operation. Per conversation with Matt Kasten, pit excavation was not able to remove all soil with >910-1 concentrations. Also per F-27, pit has been partially backfilled and ramped to allow drill rig access for soil sampling to define extent. Soil stockpiles have been incorporated into landfarm. Soil has been amended with manure and Microblaze and tilled. No petro odor or staining observed in landfarm using spade to 1ft bgs in multiple locations.

Per F-27, complete site investigation using drill rig to define extent of contamination. Submit Supplemental F-27 plan to remediate soils to Table 910-1 compliance. Any in-situ or onsite remediation requires surface owner (BLM) permission prior to implementation. Notify COGCC a minimum of 72 hrs prior to remediation activity.
