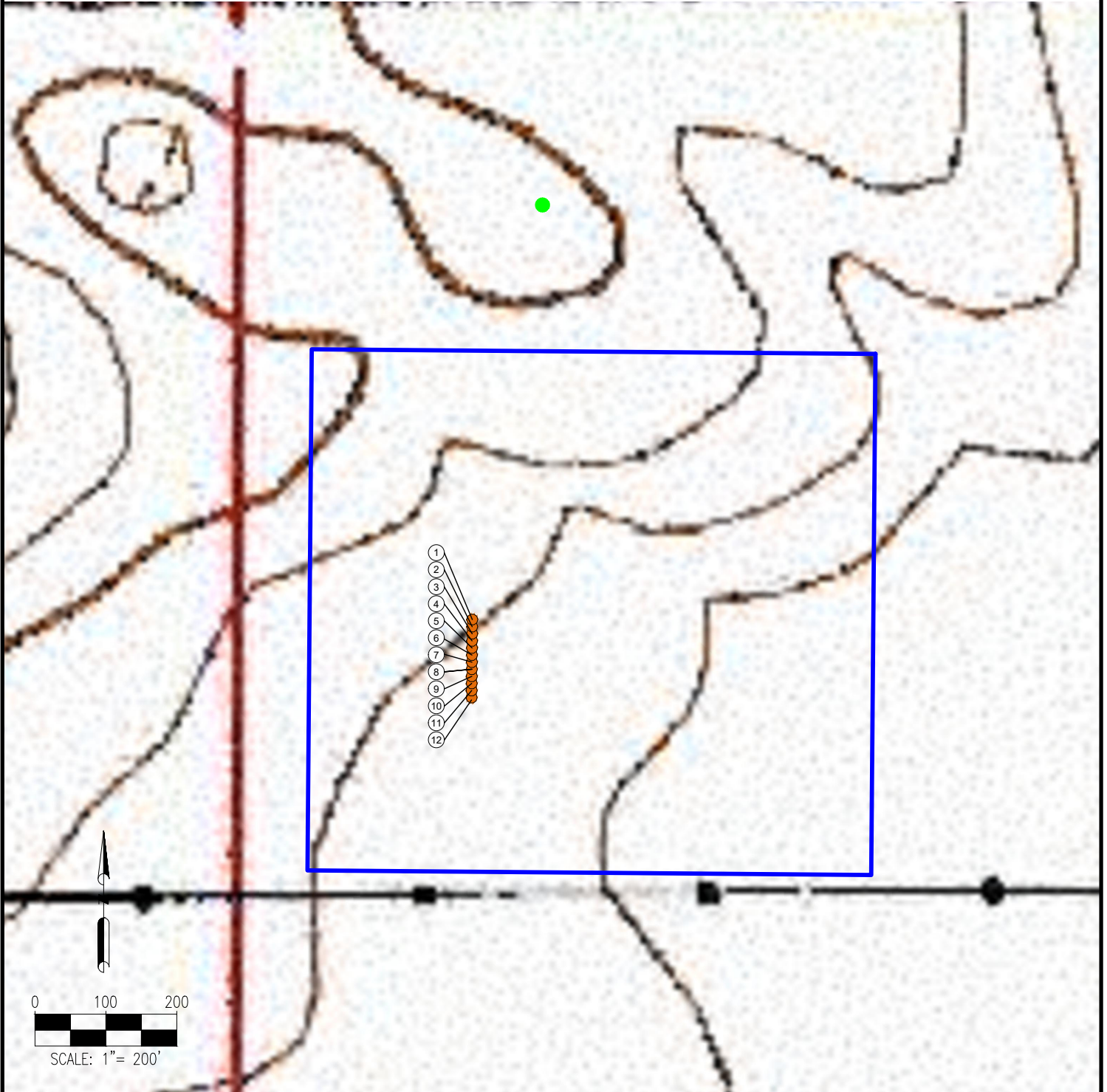


# LOCHBUIE LAND 25H-D166 PAD REFERENCE AREA MAP
