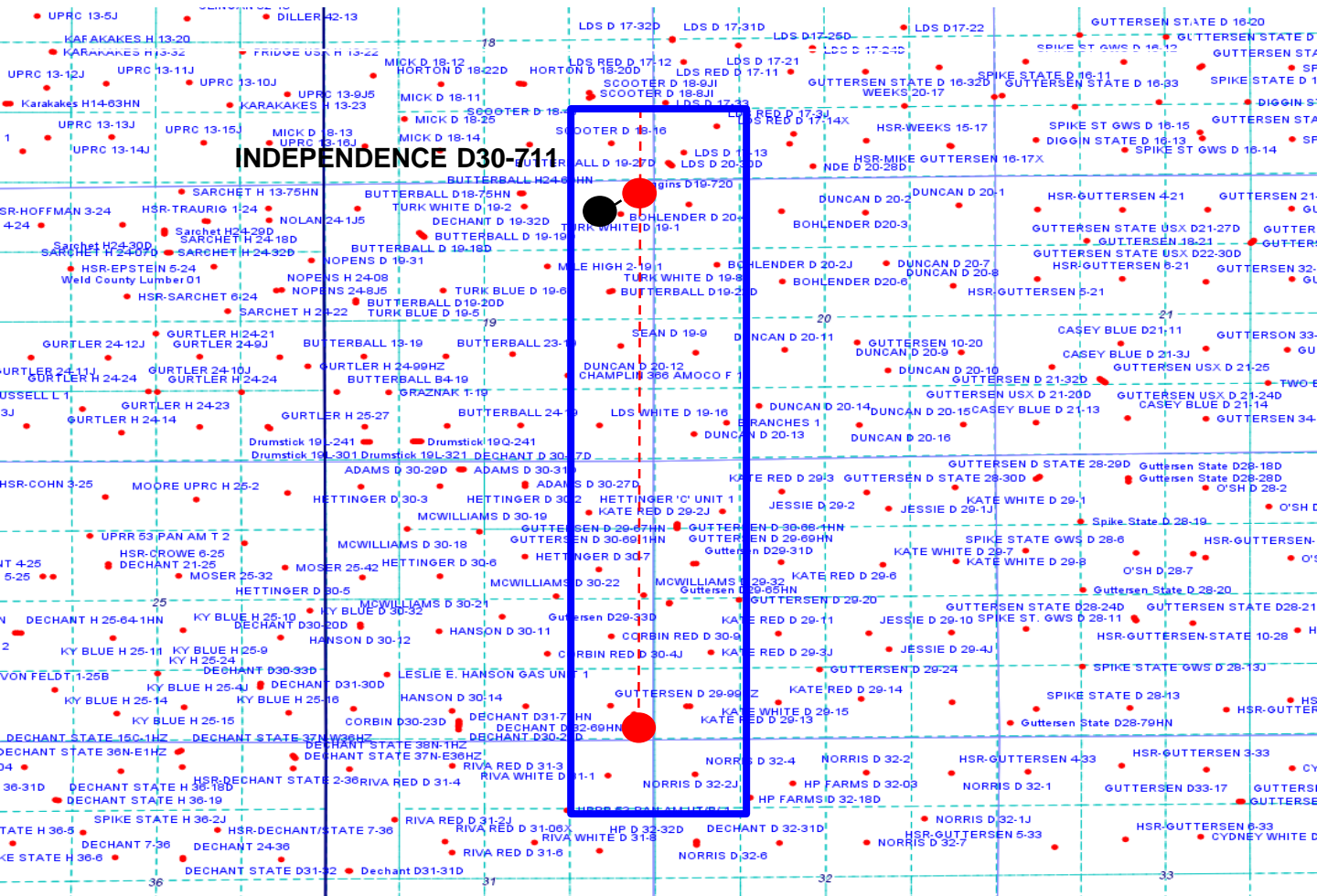

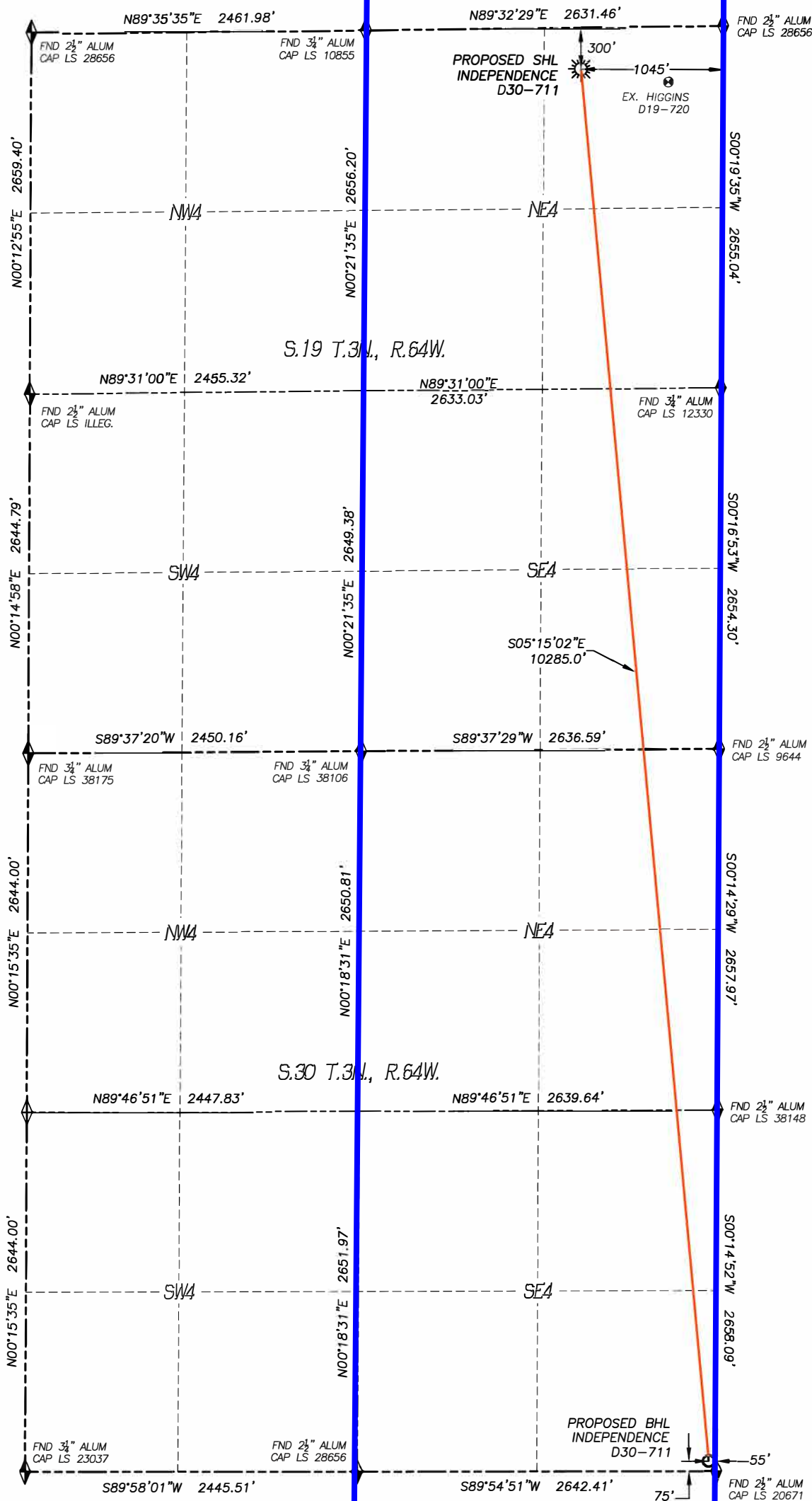
Proposed 798.672± acre spacing unit
