Comments

The nearest well with a wellbore completed in the same formation and the nearest well belonging to another operator is the E.L. Minch #25-9D, (API: [#05-123-33642]) in PR status, owned by SRC Energy Inc. Great Western will not stimulate within 150' of the E.L. Minch #25-9D without signed written consent. GWOG is in the process of obtaining consent, if consent is not granted the completion plan for this well will avoid completing the portion(s) of the lateral within 150' of the nonop well.

This well has a bottom hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback at 1514 FNL and 470 FWL of Section 9. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.
