Pit has been previously backfilled. Well was plugged in 1998, and it appears pit was closed around that time. COGCC was given 72 hours notice prior to pit sampling, but representatives were not present during sampling.

Proposed Soil Sampling

☒ Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

On 6/18/18, Wexpro Company personnel attempted to core sample the backfilled pit area (facility 116664) on the G Kuykendall 3 pad, as per the previously approved core sampling plan. The location of the pit was determined using historic Google Earth imagery and GPS coordinates. Several sample attempts were made obtain a sample of the pit in the area believed to have been the most impacted. Depths of the attempted samples ranged from 1-3' in depth, with all attempts showing no signs of pit (change in color/texture/odor/noticable pit material/liner/fill). Depths of attempted samples depended on the auger attachment's ability to go any deeper (attachment length or rock). One sample was taken from the GPS coordinates obtained from Google Earth imagery and analyzed for GRO, DRO, BTEX and PAH only, as it seemed unlikely that the sample was pit material. The depth of the analyzed sample was 9', as rocks were hit and the auger couldn't go any further. Please see attachments for sampling area.
