TEP Rocky Mountain LLC (TEP) request approval to utilize the MV 15-8 pad to temporarily stage excess material from construction of the MV 60-8D pad (Loc ID #334950, Amended Form 2A Doc #401678650). Excess material produced during construction of the MV 60-8D pad will be hauled by truck to the MV 15-8 pad and staged within three separate staging area as shown on the attached exhibit. The staging areas will be striped of topsoil prior to hauling in excess material. Some of the excess material will be use to improve the interim reclaim on the MV 15-8 pad and would remain on location of the MV 15-8 pad following reclamation of the MV 60-8D. Excess material not necessary for reclamation of the MV 15-8 pad will be hauled by truck back to the MV 60-8D pad.
