On 3-26-2018, I was contacted by COGCC staff in reference to some complaints received by the COGCC in reference to noise, and possible gas leak occurring in the Erie area originating from the Extraction, Coyote location.

On 3-26-2018, I attempted to contact the complainant. I performed a sit inspection and I contacted Crestone's central hub which monitors the Pratt location with laser gas leak detection equipment to alert them of any leaks at the Pratt location. The Crestone Hub did not show any gas leaks at the location nor were any leaks found at the time of the inspection

No violation of COGCC rules were observed at the time of the inspection of the frack operation nor in the surrounding neighborhood.
