Field Inspector Actions:

On 6-22-2018 through 6-26-2018, I observed the COGCC was receiving some complaints of odors from the Erie area. The complaint stated the odors were coming from what they thought was the Extraction, Coyote location.

During the weekend of 6-23-2018 through 6-25-2018 I wen through the neighborhood of the complaints residence several times at no time did I ever detect odors in the neighborhood.

On 6-26-2018, I attempted to contact the complaints in reference to the odors they were experiencing which they perceived as coming from the Coyote location. I went to the Extraction Coyote location and I observed that there were no personal or equipment on location. I contacted Extraction who was in flow back operations at location Extraction where changing out tank at the time of the inspection to mitigation of odors comin from location.

No violation of COGCC rules were observed at the time of the inspection of the frack operation nor in the surrounding neighborhood.
