

HAS DETERMINED THE SURFACE HOLE LOCATION OF THE GUTTERSEN Y05-749 WELL TO BE 2211' FROM THE NORTH LINE AND 2375' FROM THE WEST LINE AS MEASURED AT RIGHT ANGLES FROM THE SECTION LINES OF SECTION 29, TOWNSHIP 3 NORTH, RANGE 64 WEST, AND THE BOTTOM HOLE LOCATION TO BE 75' FROM THE SOUTH LINE AND 2085' FROM THE EAST LINE AS MEASURED AT RIGHT ANGLES FROM THE SECTION LINES OF SECTION 5, TOWNSHIP 2 NORTH, RANGE 64 WEST OF THE 6TH PRINCIPAL MERIDIAN, WELD COUNTY, COLORADO.






