COMMENTS:

Red Willow Production Company (RWPC) acquired the assets of Samson Resources Company on November 15th of 2016. The Howard 34-6-19 #1 SWD was included as part of the acquisition. The bradenhead test completed on August 15th, 2017 exceeded the threshold pressure for a non critical area (25 psig) with a surface casing pressure of 90 psig (test form attached). This pressure is 17 psi lower than the pressure that was observed in 2016. The surface casing pressure blew down to a "whisper" in 3 minutes and 20 seconds and was TSTM by 5 minutes. Since the subject well is a water disposal well, there was only one gas sample taken from the bradenhead. The 2017 sample is compositionally very close to prior samples taken over the last several years (gas analysis attached). Red Willow believes the source gas of this gas is from a shallow gas bearing formation and not an indication of a mechanical integrity issue. Red Willow proposes venting this well for two years. There are no production facilities on this location that could put the bradenhead gas to beneficial use.
