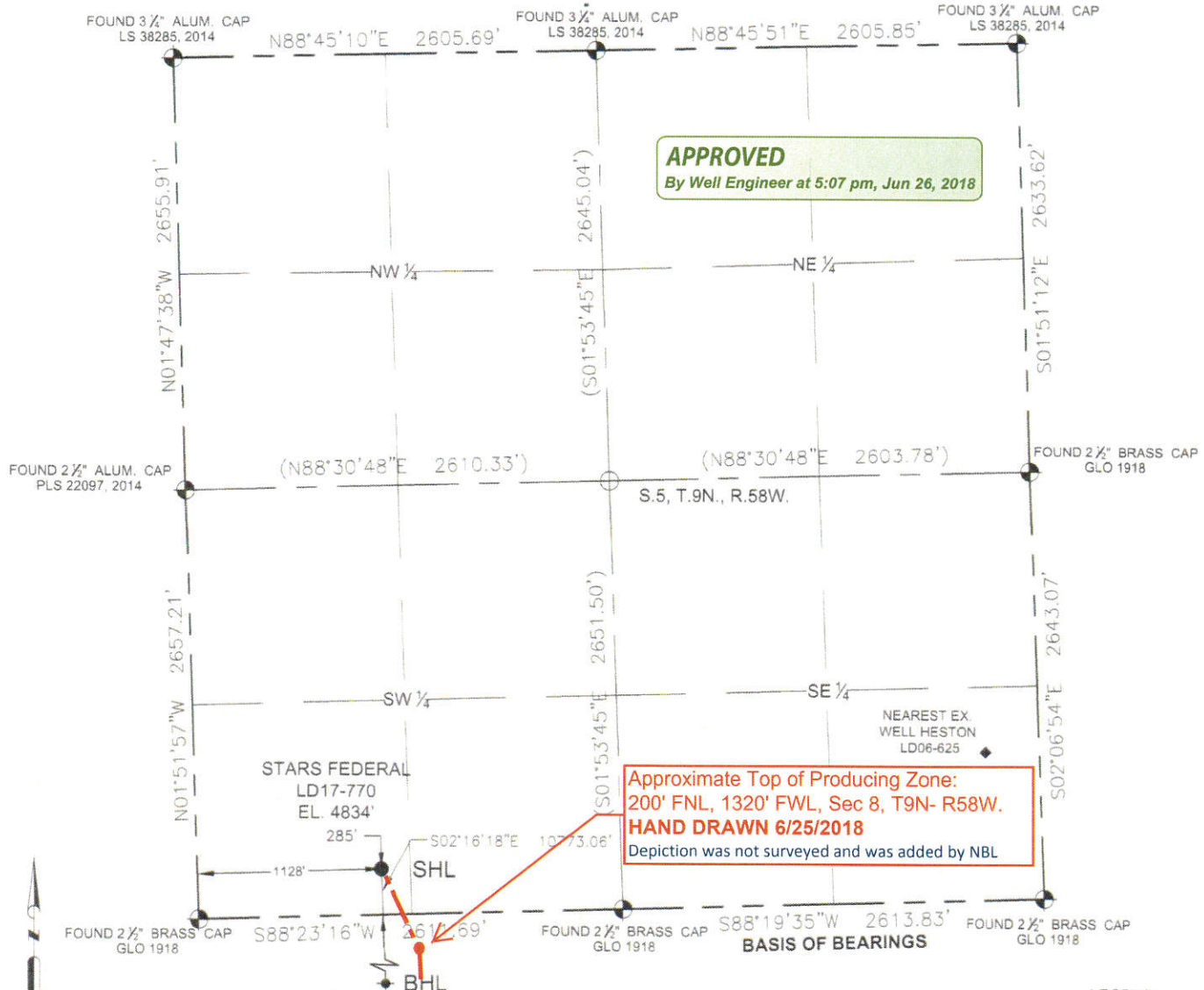


# WELL LOCATION CERTIFICATE

Petroleum Field Services, LLC has determined the surface location of the STARS FEDERAL LD 17-770 to be 1128' from the WEST line and 285' from the SOUTH line as measured at right angles from the section line of Section 5, Township 9 North, Range 58 West of the Sixth Principal Meridian, County of Weld, State of Colorado, and the bottom hole to be 1320' from the WEST line and 140' from the SOUTH line as measured at right angles from the section line of Section 17, Township 9 North, Range 58 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 04/14/16 for and on behalf of Noble Energy Inc., that this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for the establishment of fence, building, or other future improvement lines.

## Notes:

- 1) All bearings are Grid Bearings of the Colorado State Plane Coordinate System, North Zone, North American Datum 1983/2011. The bearing of the South line of the Southeast Quarter of Section 5 is S88°19'35"W between the monuments shown hereon. The lineal dimensions as shown herein are grid distances based upon the "U.S. Survey Foot." To get ground distances multiply shown distance by 1.000238434.
- 2) Ground elevations are based on an observed GPS elevation (NAVD 1988 DATUM).
- 3) NEAREST EXISTING WELL IN SECTION 05 IS: HESTON LD06-625, 3811' NE
- 4) IMPROVEMENTS: See LOCATION DRAWING exhibit for all visible improvements within 500' of disturbed area.
- 5) SURFACE USE: "RANGELAND"
