1	General Housekeeping	Visual Impacts: All long term facility structures will be painted a color that enables the facilities to blend in with the natural background color of the landscape, as seen from a viewing distance and location typically used by the public.
2	General Housekeeping	Maintain appearance with garbage clean-up; a trash bin will be located on site to accumulate waste by the personnel drilling the wells. Site will have unused equipment, trash and junk removed immediately.
3	Storm Water/Erosion Control	Implement and maintain BMPs to control stormwater runoff in a manner that minimizes erosion, transport of sediment offsite, and site degradation. Co-locate gas and water gathering lines whenever feasible, and mitigate any erosion problems that arise due to the construction of any pipeline(s).
4	Dust control	Operator shall employ practices for control of fugitive dust caused by their operations. Such practices shall include but are not limited to the use of speed restrictions, regular road maintenance, restriction of construction activity during high- wind days, and silica dust controls when handling sand used in hydraulic fracturing operations. Additional management practices such as road surfacing, wind breaks and barriers may be used.
5	Construction	Light sources during all phases of operations will be directed downwards and away from occupied structures and public roads where possible. Permanent lighting may be mounted at compressor stations on a pole or building and directed downward to illuminate key areas within the facility, while minimizing the amount of light projected outside the facility.
6	Emissions mitigation	When commercial quantities of salable quality gas are achieved at each well, the gas shall be immediately directed to a sales line or shut in and conserved. If a sales line is unavailable or other conditions prevent placing the gas into a sales line, the operator shall not produce the wells without an approved variance per Rule 805.b.(3)C.
7	Odor mitigation	Oil & gas facilities and equipment shall be operated in such a manner that odors and dust do not constitute a nuisance or hazard to public welfare.
8	Drilling/Completion Operations	Anti-collision: Operator will perform an anti-collision evaluation of all active (producing, shut in, or temporarily abandoned) offset wellbores that have the potential of being within 150 feet of a proposed well prior to drilling operations for the proposed well. Notice shall be given to all offset operators prior to drilling.
9	Interim Reclamation	Operator shall be responsible for segregating the topsoil, backfilling, re-compacting, reseeding, and re-contouring the surface of any disturbed area so as not to interfere with Owner's operations and shall reclaim such area to be returned to pre-existing conditions as best as possible with control of all noxious weeds.

10	Final Reclamation	<p>Operator has an MLVT Design Package, certified and sealed by a licensed professional engineer, which is on file in their office and available upon request. The site shall be prepared in accordance with the specifications of the design package prior to tank installation; including ensuring that proper compaction requirements have been met.</p> <p>The MLVT will be at least 75 feet from a wellhead, fired vessel, heater-treater, or a compressor with a rating of 200 horsepower or more. 1	<p>CPW has mapped burrowing owl and swift fox potential habitats located in and near this proposed development.</p> <p>Therefore, CPW recommends that the operator (or its biologist) conduct an initial site visit to determine if there are prairie dog burrows (for burrowing owls) and/or larger dens (for swift fox) in and near the site boundaries.</p> <p>If prairie dogs are present, then CPW recommends that the operator survey for burrowing owls if initial site disturbance will occur in prairie dog towns during the owls nesting season (March 15 through October 31). Burrowing owl survey protocol can be found here: https://cpw.state.co.us/Documents/WildlifeSpecies/LivingWithWildlife/RecommendedSurveyOwls.pdf</p> <p>If larger (~8-inch) dens are present, and initial site disturbance will occur during the swift foxes denning season (April 1 through June 30), then CPW recommends that the operator contact us for swift fox survey protocol.</p> <p>CPW appreciates the collaboration, as we strive for responsible energy development while protecting sensitive habitats.</p> <p>Should the operator have any questions and/or request a site visit with CPW, please contact CPWs Northeast Region Energy Liaison (Brandon Marett) at (303) 291-7327.</p>	09/06/2017
