-The BHL extends 135 feet beyond the production zone.
-This well has a bottom-hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback at 1848' FNL and 460' FWL of Section 4. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.
-Nearest wellbore permitted or completed in the same formation is the Property Reserve 4-65 3-4 2AH and Property Reserve 4-65 3-4 2CH(Burlington Operating).
-Nearest existing or permitted wellbore belonging to another operator is the Westan-Fistchahs 1 (Amoco Production Company).

1	Drilling/Completion Operations	One of the first wells drilled on the pad will be logged with open-hole Resistivity Log and Gamma Ray Log from the kick-off point into the surface casing. All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "No open-hole logs were run" and shall clearly identify (by API#, well name & number) the well in which open-hole logs were run.
2	Drilling/Completion Operations	If a skid is performed for the subject well, then the only required BOPE tests will be for any broken BOPE connections, as long as a full BOPE test was performed at the beginning of the pad, and as long as all necessary BOPE tests are completed at least every 21 days during the pad operations.
