- The BHL extends 135 feet beyond the production zone.
- This well has a bottom-hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback at 2166' FSL and 460' FEL/FWL of Section 12. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.
- Nearest wellbores permitted or completed in the same formation are the Prosper Farms 4-65 11-12 3AH & Prosper Farms 4-65 11-12 3CH (Burlington Resources Oil and Gas LP).
- Nearest existing or permitted wellbore belonging to another operator is the Westan-Fischahs #1 (Amoco Production Company).

1	Drilling/Completion Operations	One of the first wells drilled on the pad will be logged with open-hole Resistivity Log and Gamma Ray Log from the kick-off point into the surface casing. All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "No open-hole logs were run" and shall clearly identify (by API#, well name & number) the well in which open-hole logs were run.
2	Drilling/Completion Operations	If a skid is performed for the subject well, then the only required BOPE tests will be for any broken BOPE connections, as long as a full BOPE test was performed at the beginning of the pad, and as long as all necessary BOPE tests are completed at least every 21 days during the pad operations.
