4. TIH with tubing to 1600'. RU cementing company. Mix and pump 40 sxs 15.8#/gal CI G cement down tubing (Pierre coverage from 1600'-1100').
5. Pickup tubing to 568'. Mix and pump 45 sxs 15.8#/gal CI G cement down tubing. Cement should circulate to surface. TOOH with tubing.
6. Cut surface casing 6' below ground level and weld on cap.
