### ALLEGED VIOLATION

Description of Alleged Violation:

Pursuant to Rule 210.b, within 60 days after the completion of a well or the installation of a battery, Huntington Energy LLC ("Operator") shall install a permanent sign at the wellhead. This sign shall provide, among other required information, a phone number at which the Operator can be reached at all times and a phone number for local emergency services (911 where available). During an inspection of Operator's Fossil Federal 6-18 facility (Location ID 279485, API 05-113-06199 "Location") on December 5, 2017 (Field Inspection Report No. 680402250), COGCC Staff observed that the signage at the Location did not include a phone number at which the Operator can be reached at all times or a phone number for local emergency services. In Field Inspection Report No. 680402250, COGCC Staff required Operator to modify the signage to include emergency contact information by January 5, 2018. During the follow up inspection on January 11, 2018 (Field Inspection Report No. 680402375), COGCC Staff observed that the signage had not been modified to include emergency contact information. On April 19, 2018, Operator emailed COGCC Staff a photo showing the Operator contact number was added to the sign, but still no number for local emergency services was posted. Operator failed to timely install a permanent sign with the required information at the Location, in violation of Rule 210.b.

Abatement or Corrective Action Required to be Performed by Operator:

Corrective Action Due Date: 08/17/2018

**Proper and timely abatement does not preclude the assessment of penalties and an Order Finding Violation.**

Operator shall immediately install signage at the Location that includes a phone number for local emergency services (911 if available).

### PENALTY


Penalties for violations alleged in this NOAV will be calculated pursuant to Rule 523, with daily penalties accruing pursuant to Section 34-60-121(1), C.R.S.

### ANSWER

Pursuant to Rule 522.d.(2), the operator must file an Answer to this NOAV within 28 days of its receipt, or a default judgement may be entered.
