Field Inspector Actions:

On 8/14/2018; I received a complaint in regard to C-scale vibration, suspected to be coming from the Hawkstone 29-30DD facility, owned and operated by Bayswater.

On 8/14/2018, I performed a complete inspection of the facility (436310). The well was hard shut in at the wellhead. Additionally, the equipment on location was de-energized, including VOC combustors. I have also inspected a facility west of the complainant's subdivision and found the well hard shut in as well as de-energized equipment.

After speaking with the complainant, of my findings, I have referred him to local government as we have eliminated the source of C-scale from being an oil & gas issue.

No violation of COGCC rules were observed at the time of the inspection.

All information reviewed and site inspection information were submitted to the complaint specialist for further review.
