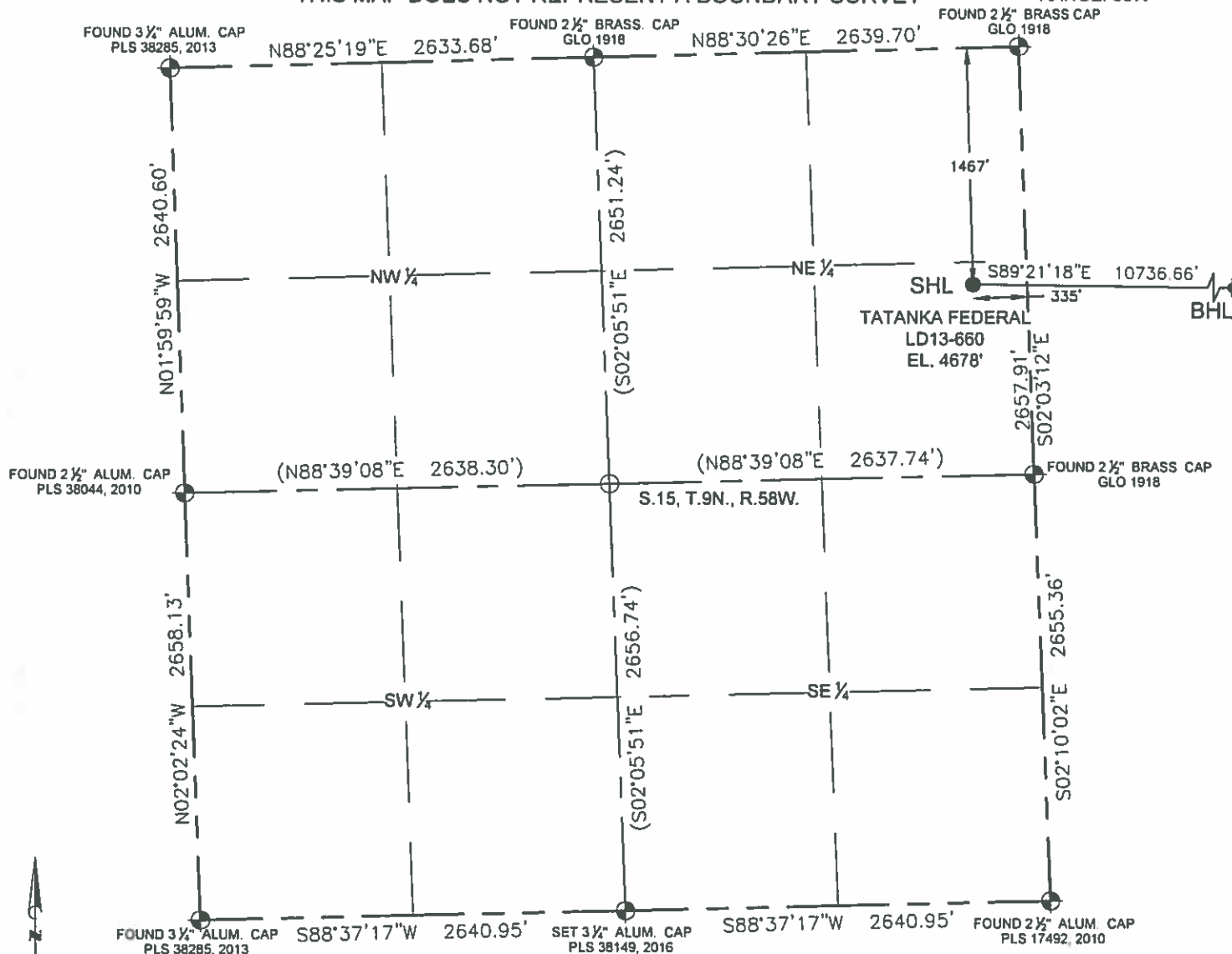


# WELL LOCATION CERTIFICATE

Petroleum Field Services, LLC has determined the surface location of the TATANKA FEDERAL LD13-660 to be 335' from the EAST line and 1467' from the NORTH line as measured at right angles from the section line of Section 15, Township 9 North, Range 58 West of the Sixth Principal Meridian, County of Weld, State of Colorado, and the bottom hole to be 140' from the EAST line and 1860' from the NORTH line as measured at right angles from the section line of Section 13, Township 9 North, Range 58 West of the Sixth Principal Meridian, County of Weld, State of Colorado.
