



WELL LOCATION CERTIFICATE

Petroleum Field Services, LLC has determined the surface location of the **TATANKA FEDERAL LD13-685** to be 335' from the EAST line and 1392' from the NORTH line as measured at right angles from the section line of Section 15, Township 9 North, Range 58 West of the Sixth Principal Meridian, County of Weld, State of Colorado, and the bottom hole to be 140' from the EAST line and 440' from the NORTH line as measured at right angles from the section line of Section 13, Township 9 North, Range 58 West of the Sixth Principal Meridian, County of Weld, State of Colorado.
