Decompact soils by cross ripping to a minimum depth of 18 inches. Reseed the location and access road to facilitate vegetation establishment. Stabilize the disturbed soils until vegetation establishes (e.g. weed free mulch)" by 4/28/2017.</p> <p>Operator appears to have submitted doc. #401294492 on 5/26/2017 in response to corrective actions from inspection #673504009. Operator indicates that a variance will be submitted for the road.
