Quarterly groundwater monitoring will continue until four consecutive quarters of monitoring data indicate BTEX concentrations are in compliance with the applicable COGCC Table 910-1 groundwater standards.

Groundwater monitoring will be conducted quarterly at eight monitoring wells (BH01 - BH08) and one remediation pipe (PIPE). Groundwater samples will be submitted to Summit Scientific Laboratories in Golden, Colorado for analysis of benzene, toluene, ethylbenzene, and total xylenes (BTEX) by USEPA Method 8260B. Quarterly groundwater monitoring will be completed until four consecutive quarters of BTEX concentrations in compliance with regulatory standards are achieved.
