Steven,

Byron is working consistent with the COA in the Form 27, attached above. The Form 27 requires that two actions take place on or before August 31, 2018.

The Commission Staff's application at Docket No. 180600130 was however continued until the September 17-18 hearing of the Commission. As part of our ongoing negotiations toward an AOC, Byron desires to include a plan to plug and abandon the Dagenhart #1 well. However, Byron has identified significant efficiencies that may be gained by completing the work detailed in the Form 27 and plugging and abandoning the Dagenhart #1 well contemporaneously.

These matters being interrelated, Byron respectfully proposes to amend the Form 27 such that the AOC's detailed therein be completed on/before **September 30, 2018**.
