Comment:

This location is not in compliance with Rule 1004. Reclamation rules require reclamation activities to be conducted within three months of plugging on cropland. Well was plugged 11/30/2016. All reclamation work should have been conducted by 2/28/2017. Operator has failed to perform final reclamation activities at the tank battery location.

Appears the well location and well access road meet Rule 1004 standards. Unable to find evidence of oil and gas activities and/or disturbances. Well location and access road appear reflective of reference crop areas.

Corrective Action: **Perform final reclamation activities at the tank battery location per Rule 1004. Corrective action is being back-dated to when all reclamation work should have been conducted.**
