5	Drilling/Completion Operations	<p>Oil-Based Drilling Fluids and Drill Cuttings Waste Management</p> <p>Oil-based drilling fluids (OBDF) will be separated from the cuttings at surface. At the end of its use on a particular well, the liquid oil-based mud will be reused for additional drilling operations or it will be returned to then vendor who originally supplied the mud. Transportation will occur on a daily basis as required to facilitate on ongoing drilling operations.</p> <p>Oil-based drill cuttings (OBDC) will be separated from liquid mud onsite and the cuttings will be temporarily stored onsite in steel bins. Accumulated cuttings will be transported for permanent disposal to a licensed solid waste disposal facility. The actual solid waste disposal facility that will be used will depend on geographic proximity to the well being drilled. Transportation will occur on a daily basis as required to facilitate ongoing drilling operations.</p>
