Producing at LG 04-16 Production Facility located to the East of the LG 04-15 PAD.</p> <p>Spill Prevention Control and Countermeasures (SPCC) plans are in place to address any possible spill associated with Oil &amp; Gas operations throughout the state of Colorado in accordance with CFR 112.</p> <p>Noble (NBL) respectfully request to submit this Form 2A as a new application. Location ID: 422939 (McClellan PC LG04-15) site has been reclaimed and the well has a status of P&amp;A. Please also note that the Grey #1 (05-123-10256) has a status of P&amp;A and this location has been reclaimed. A fence line perimeter has been set for Location ID: 435720 (Bulleit Federal PC LG04-62HN) and Location ID: 432140 (McClellan LG09-72HN). Noble does not intend to disturb these active areas. If spills occur prompt cleanup is required to minimize any commingling of waste materials with stormwater runoff. Routine maintenance will be limited to fueling and lubrication of equipment. Drip pans will be used during routine fueling and maintenance to contain spills or leaks. Any waste product from maintenance will be containerized and transported offsite for disposal or recycling. There will be no major equipment overhauls conducted onsite. Equipment will be transported offsite for major overhauls. Cleanup of trash and discarded materials will be conducted at the end of each work day. These materials will be disposed of properly.
2	Storm Water/Erosion Control	Stormwater management plans (SWMP) are in place to address construction, drilling, and operations associated with Oil & Gas development throughout the state of Colorado in accordance with Colorado Department of Public Health and Environment (CDPHE) and General Permit No.'s: COR03N578; COR03N579; COR03N580; and COR03O059. BMP's will be constructed around the perimeter of the site prior to, or at the beginning of construction. Specific BMP's used may include stockpile stabilization, grading, sediment traps, and perimeter barriers based on final construction design and will remain in place until the pad reaches final reclamation.
3	Dust control	Speed limits will be enforced. The traffic plan and route will include mitigation of impacts from temporary operations by applying water or magnesium chloride as dust suppression within 1000' of occupied residences and on lease roads as necessary in cooperation with the county.
4	Construction	<ol style="list-style-type: none"> <li>1. A contiguous spray liner will be installed and will underlay the entire tank battery. The location of a partially buried cement water vault will be excavated prior to liner install.</li> <li>2. A 60 bbl cement water vault will be utilized to collect excess produced water from oil tanks. Produced water in the vault will be removed as needed and disposed of in an approved UIC disposal well. The cement water vault is one piece with no seams designed to minimize potential for leaks. All piping associated with the use of the water vault will be aboveground and visually inspected on a regular basis.</li> <li>3. The partially buried cement water vault will be installed above the spray in liner.</li> <li>4. A sized steel secondary containment ring will be installed surrounding the entire tank batter. Sand and gravel bedding will be installed to protect the liner prior to placing equipment in the containment area.</li> </ol>
5	Odor mitigation	D822, which is relative to diesel has fewer aromatic hydrocarbons, is less flammable and contains less BTEX will be used as the base fluid for the oil based drilling fluid.
