5/29/18: MI, RU, check psi: 450/450/0 psi, pressure test pump lines and BOPs, SWI.

5/30/18: Check psi: 450/450/0 psi, blow pressure down, circulate well with 140 BBLs of water, ND WH, NU BOPs, TOOH, tally and stand back 218 JTS and lay down the rest on float, RU WL to go in and set CIBP @7039', RD WL, load well with 20 BBLs of water, pressure test plug to 500 psi, held good, TIH with 220 JTS, SWI.

5/31/18: Check psi: 0/0/0 psi, run in 3 JTS and 2-10'subs to tag plug @7039', RU CMT equipment to pump 35sxs balance plug (7039'-6428'), lay down 143 JTS to leave 80 JTS in the hole (EOT @2500'), RU CMT equipment to pump 25sxs balance plug (2500'-2170'), lay down 62 JTS to leave 18 JTS in hole (EOT@566'), pump CMT up to surface, lay down TBG, top off well with CMT (50sxs top plug), SWI, RD MO.
