Comment: Since the previous inspection on 7/30/2018, the surface owner has recently cultivated the ~30 acre parcel, including portions of this P&A location. However, Operator has failed to perform the previous corrective actions to re-contour disturbance areas to match the surrounding landscape and to remove all equipment. Equipment has been flagged and a recent "Locate" was performed. Unclear whether the "Locate" was conducted by the surface owner because of the recent cultivation or whether the Operator was responding to the corrective action.
