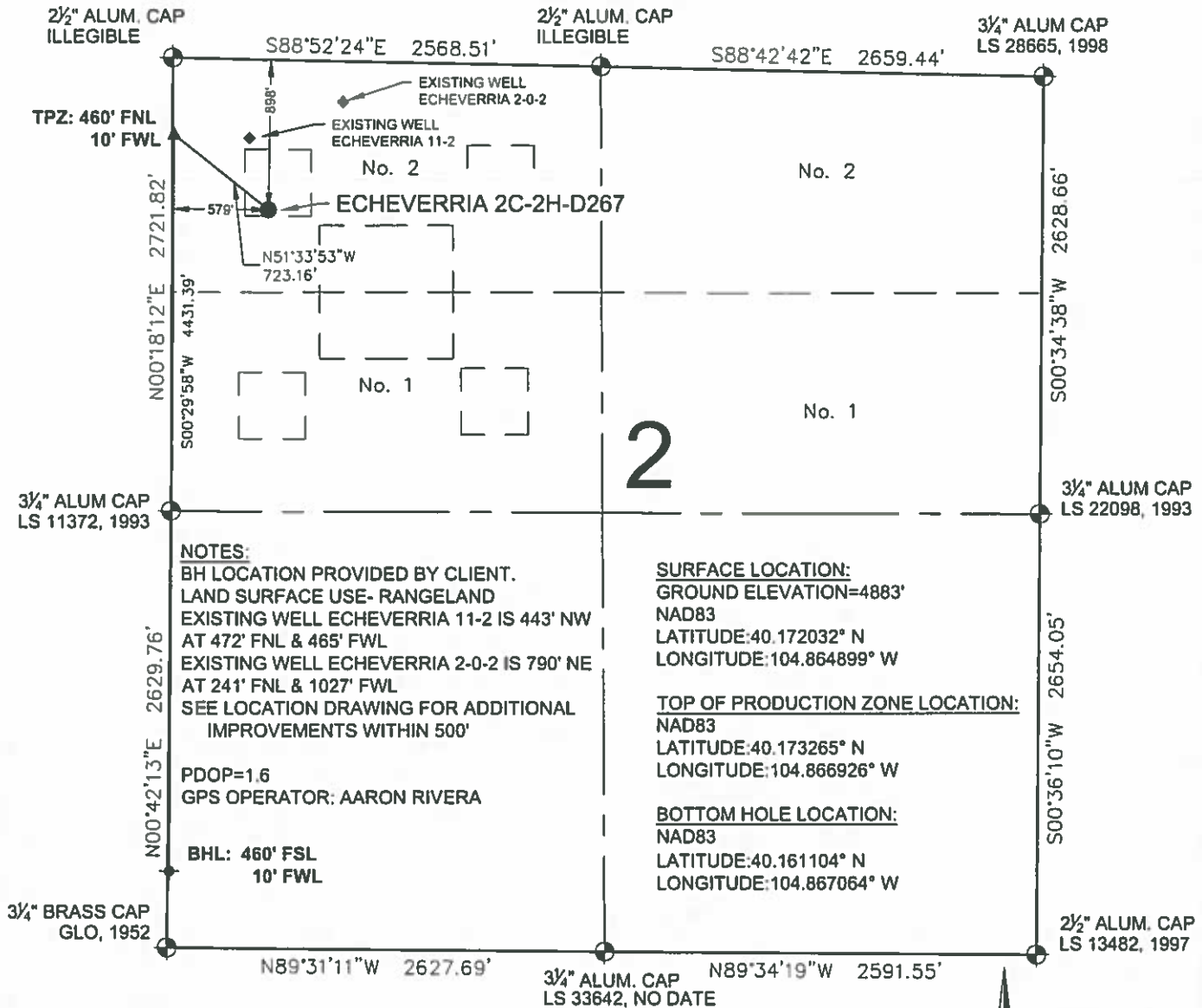


ECHEVERRIA 2C-2H-D267 WELL LOCATION EXHIBIT
