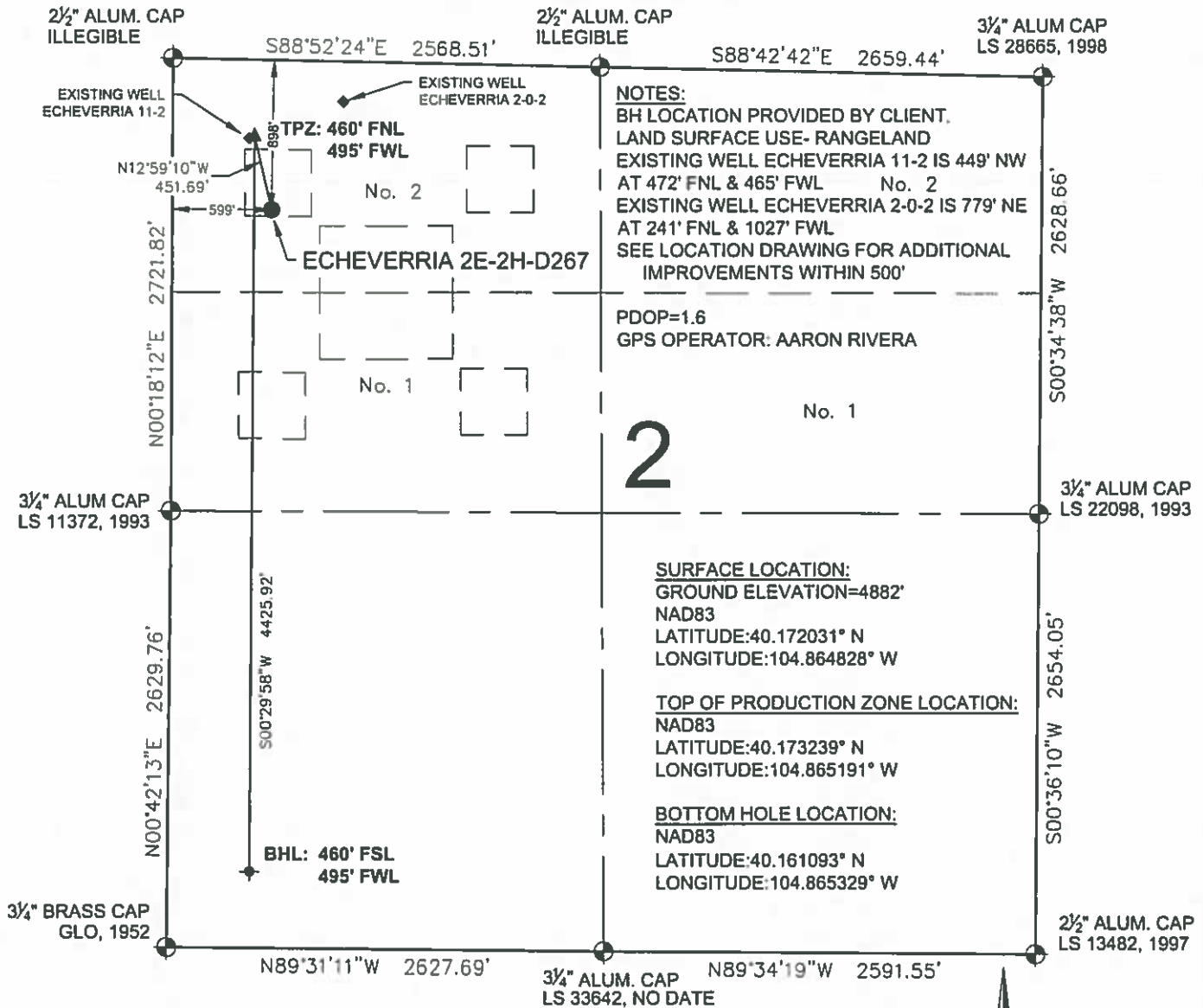


ECHEVERRIA 2E-2H-D267 WELL LOCATION EXHIBIT
