Wexpro proposes to drill four water monitoring wells located in Section 4, Township 11 North, Range 97 West. Access will be from existing roads, there will not be any surface clearing or sage brush removal. A drilling scope of work is attached. Once the wells are completed, the locations will have an as-drilled survey prepared and data provided to all regulating agencies. The well driller will be responsible for filing for the drill permit with the Colorado Board of Examiners. Once wells are drilled baseline water samples will be obtained and analyzed per Rule 609.e.; with results submitted via Sundry Notice, Form 4.
