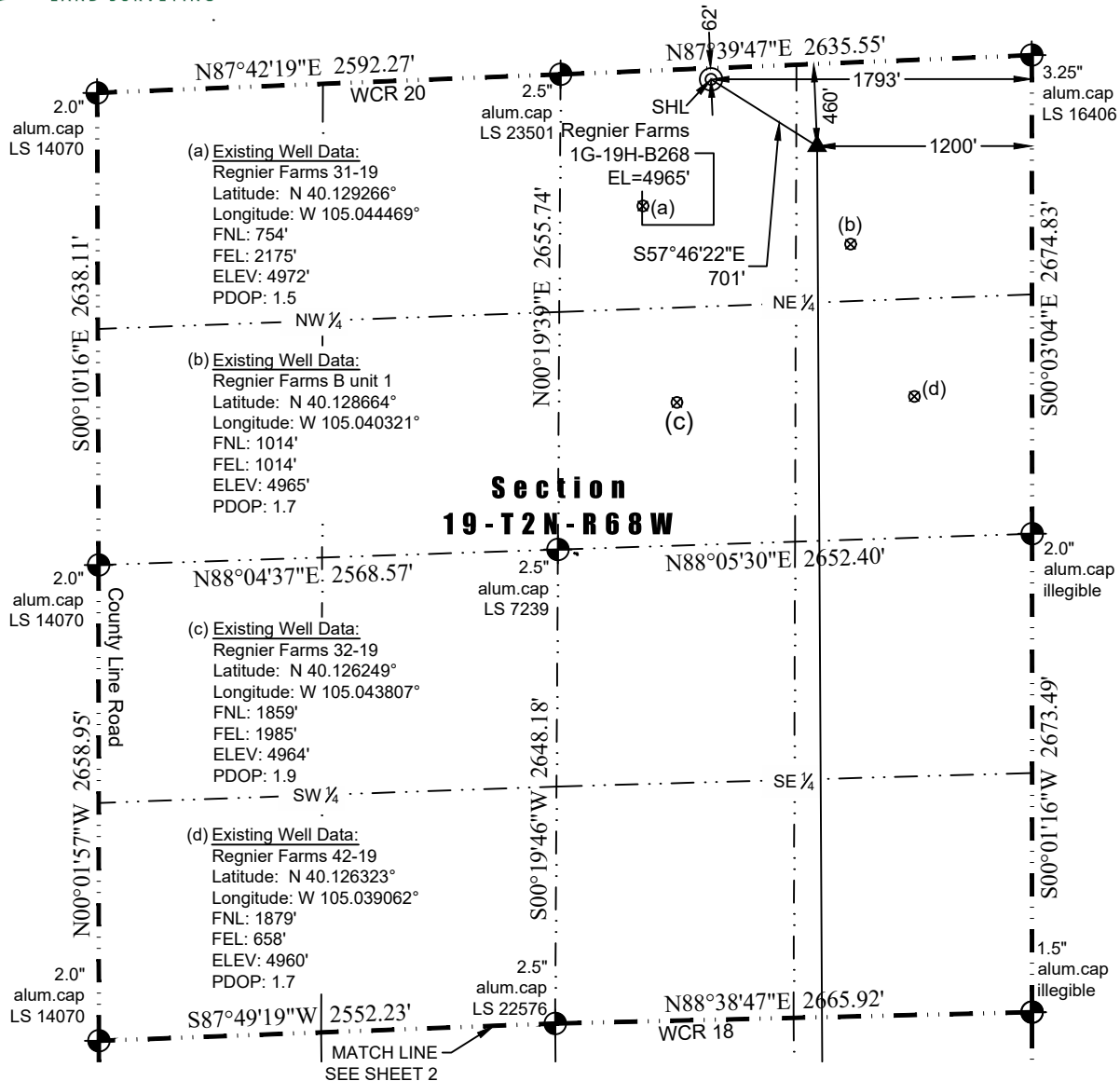


# WELL LOCATION CERTIFICATE

In accordance with a request from Jay Knutson of Crestone Peak Resources, Washburn Land Surveying, LLC has determined the location of the **Regnier Farms 1G-19H-B268** well site to be SHL: 62' FNL and 1793' FEL, (TPZ: 460' FNL and 1200' FEL), (BHL: 460' FSL and 1130' FEL), as measured at ninety (90) degrees from the section lines of Sections 19, 30 & 31 Township 2 North, Range 68 West of the 6th Principal Meridian, Weld County Colorado.

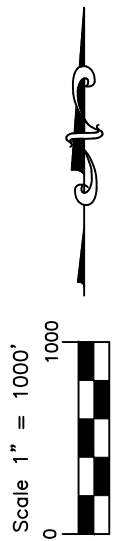
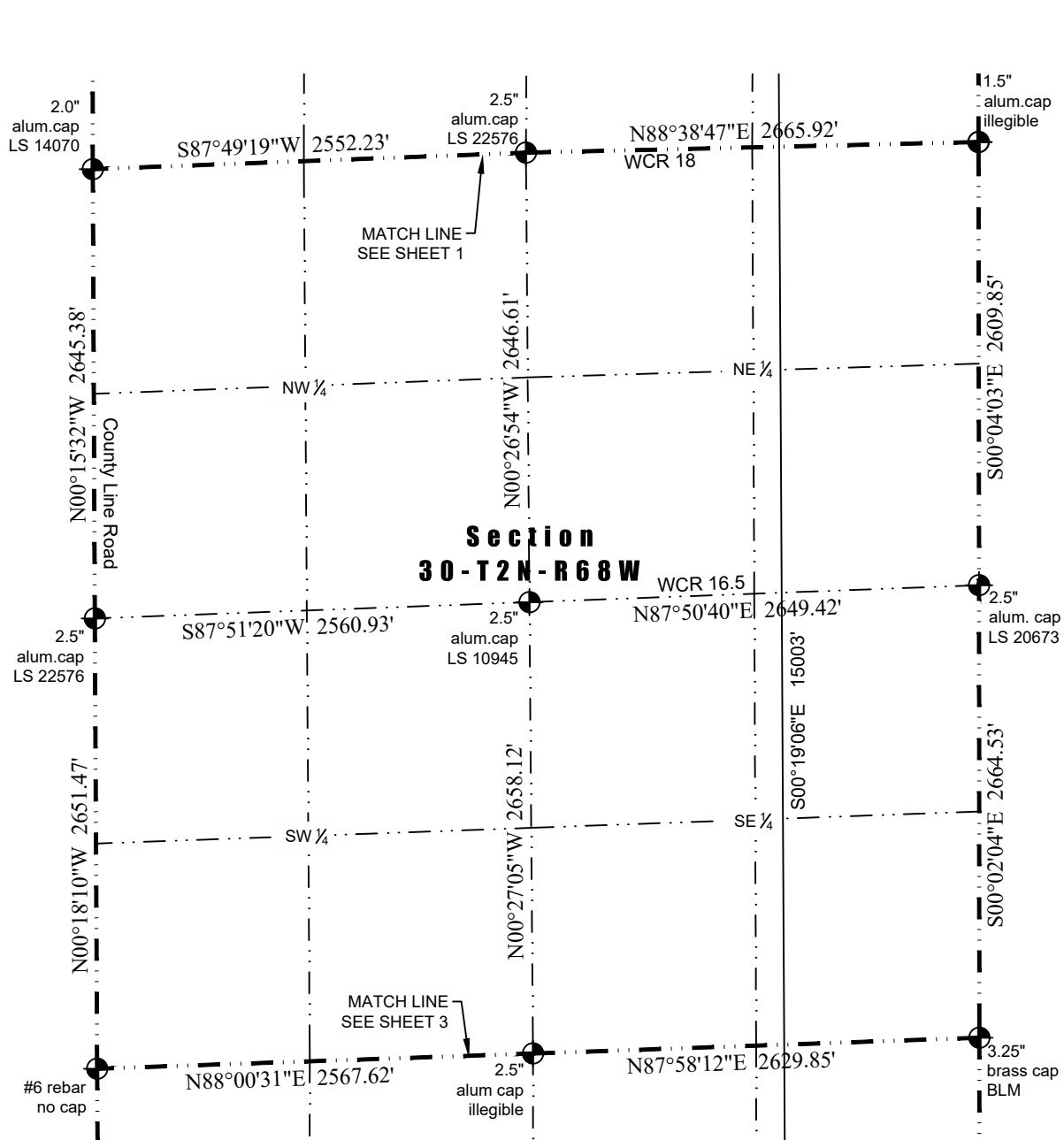

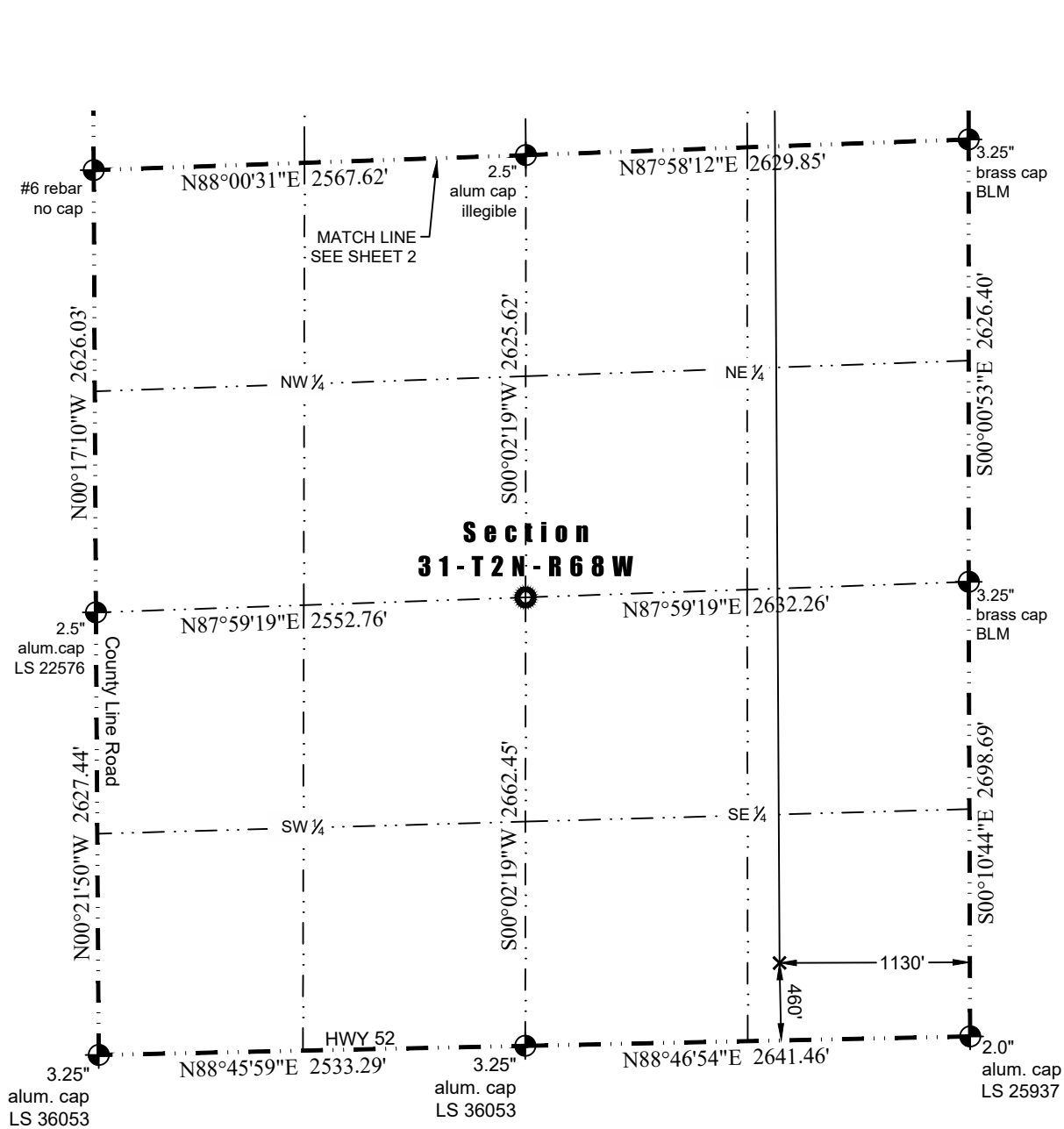
