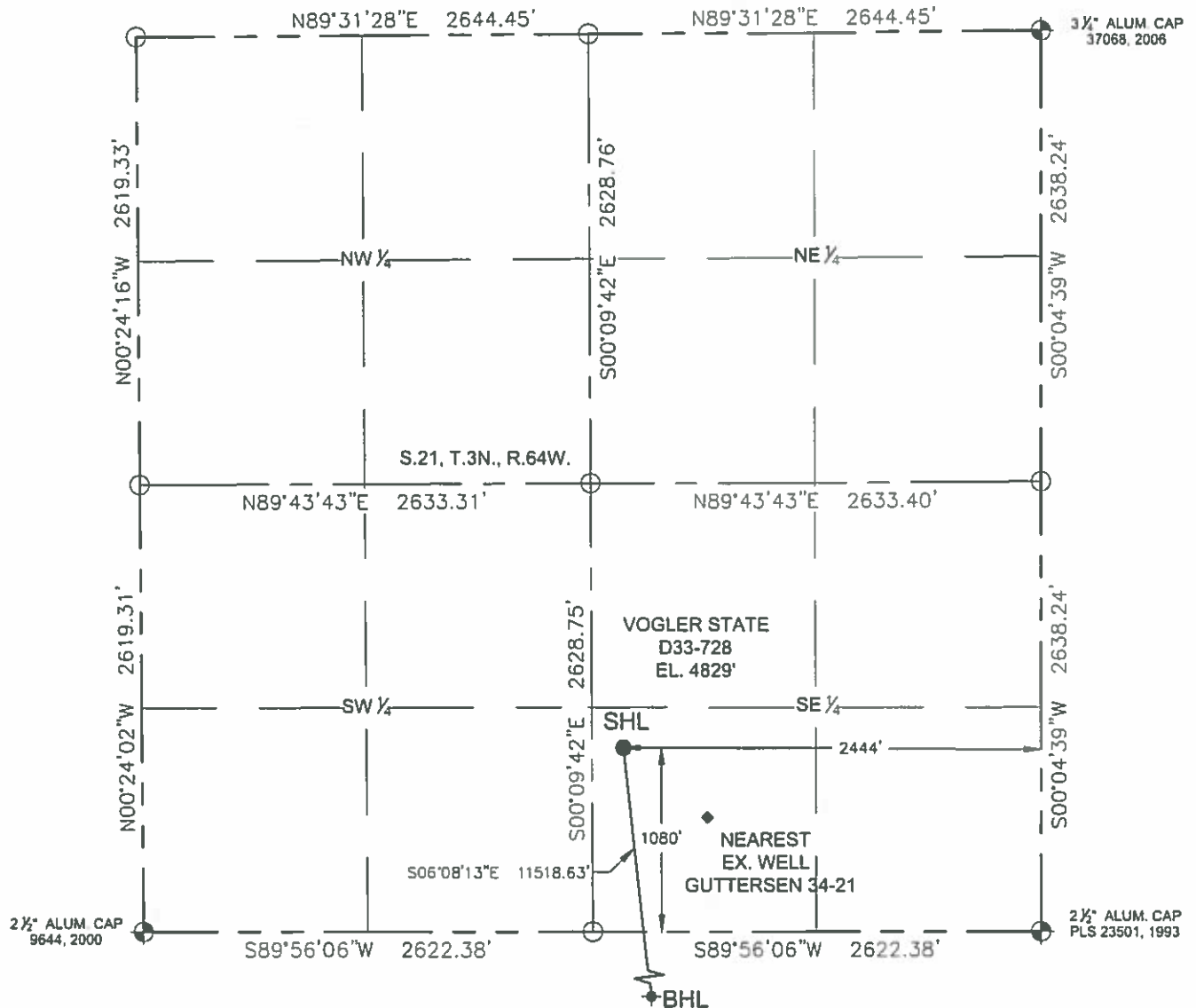


WELL LOCATION EXHIBIT

Petroleum Field Services, LLC has determined the surface location of the **VOGLER STATE D33-728** to be 2444' from the EAST line and 1080' from the SOUTH line as measured at right angles from the section line of Section 21, Township 3 North, Range 64 West of the Sixth Principal Meridian, County of Weld, State of Colorado, and the bottom hole to be 1320' from the EAST line and 200' from the SOUTH line as measured at right angles from the section line of Section 33, Township 3 North, Range 64 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

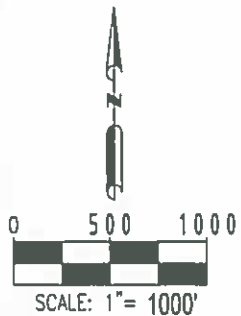

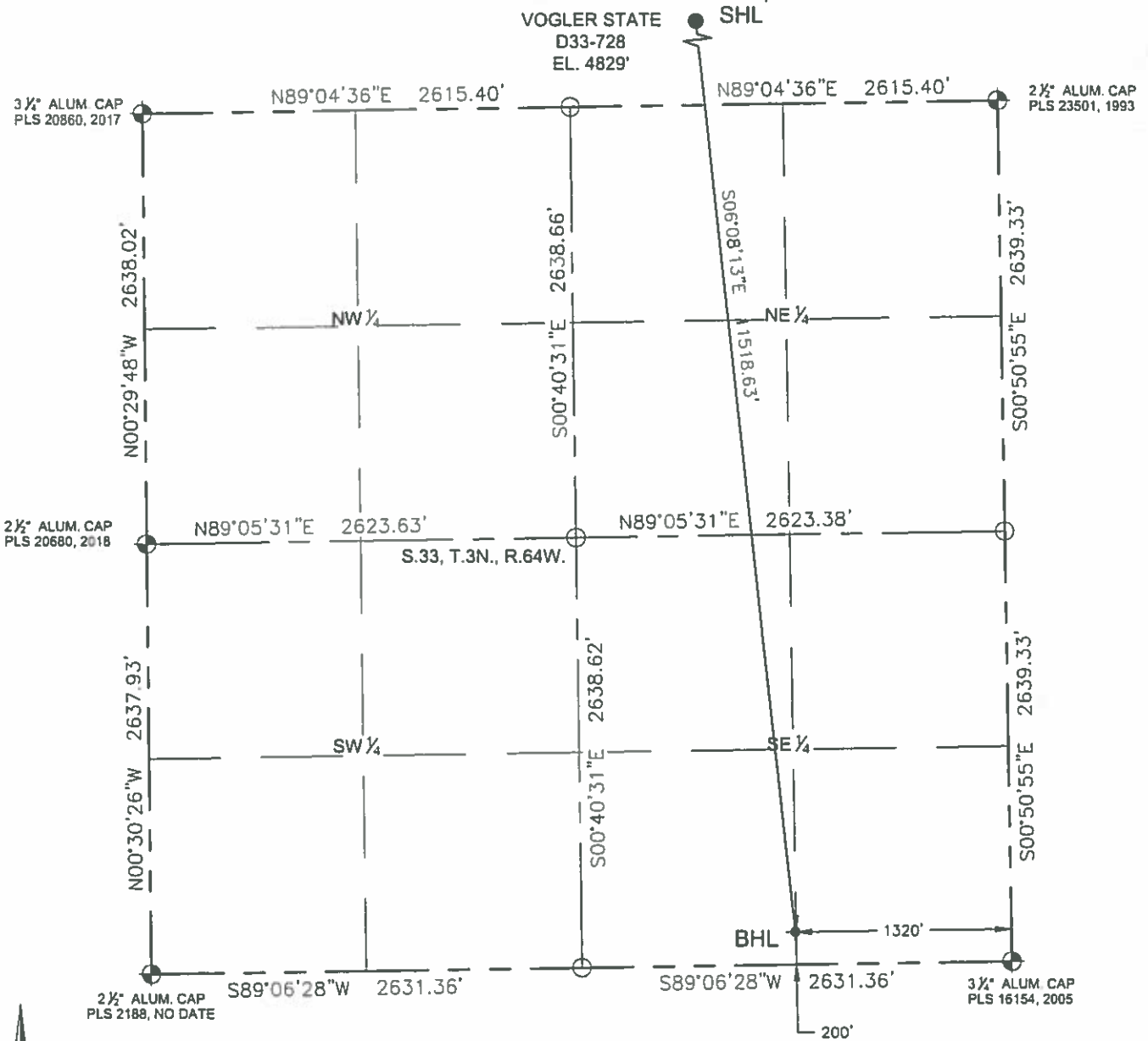
