In response to Inspection No. 675100562, Encana Oil and Gas (USA) Inc. has made thorough review of the COGCC Rules and Regulations, specifically Rule 210 (Signs & Markers) and Rule 605 a(12) (Labeling of Tanks), and cannot find a preclusion against the use of multiple NFPA labels on tanks. Additionally, Encana's use of multiple NFPA labels is an established practice on locations that make use of two-phase separation. Encana contends that use of dual NFPA labels on tanks on certain locations is the only accurate way of correctly capturing the tank contents to comply with COGCC rule 210.

A Form 42 will be submitted addressing the remaining corrective actions associated with this inspection by the corrective action date.
