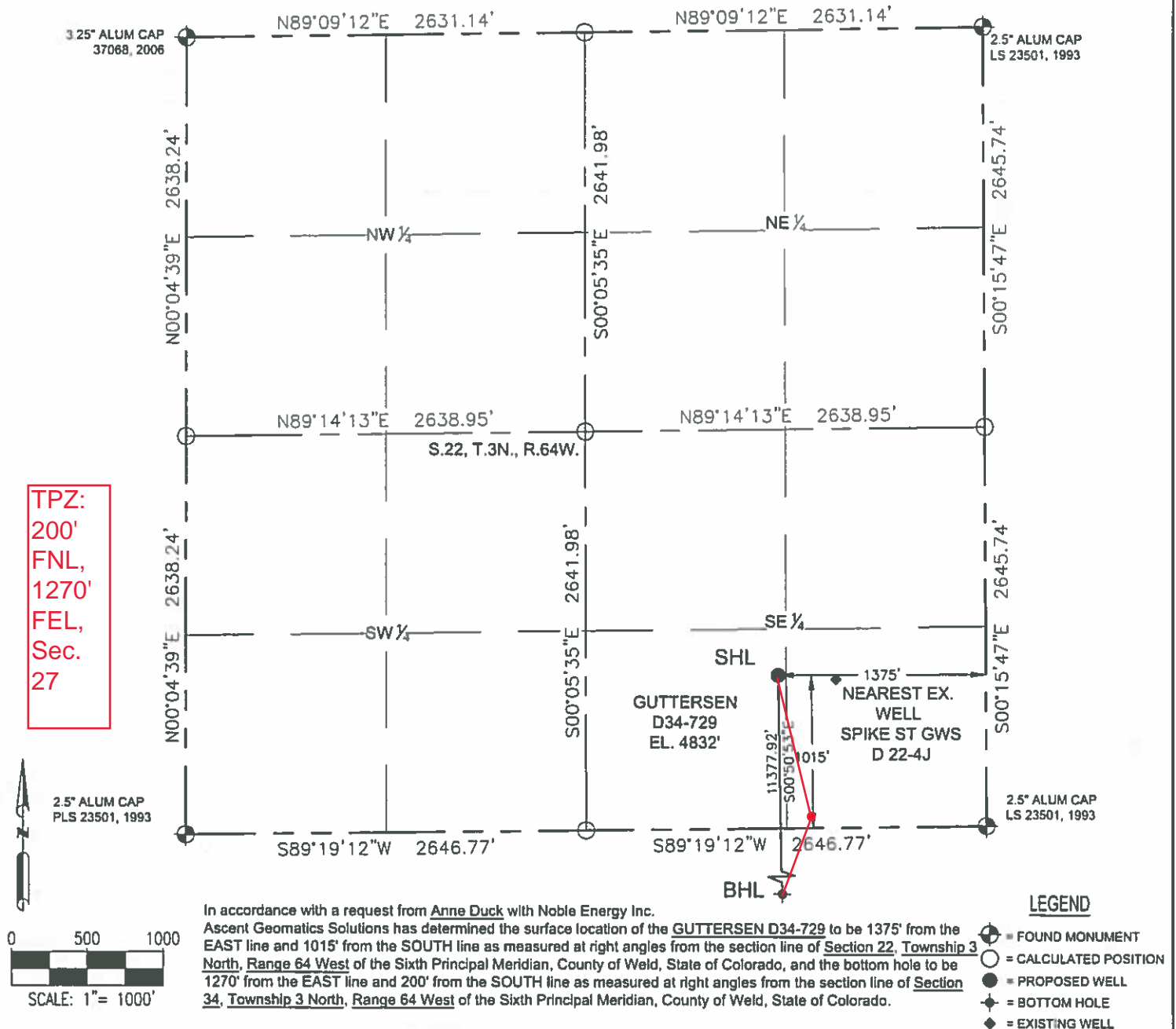


WELL LOCATION EXHIBIT

Ascent Geomatics Solutions has determined the surface location of the GUTTERSEN D34-729 to be 1375' from the EAST line and 1015' from the SOUTH line as measured at right angles from the section line of Section 22, Township 3 North, Range 64 West of the Sixth Principal Meridian, County of Weld, State of Colorado, and the bottom hole to be 1270' from the EAST line and 200' from the SOUTH line as measured at right angles from the section line of Section 34, Township 3 North, Range 64 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Exhibit was prepared by me, or under my direct supervision, that the fieldwork was completed on 04/11/18 for and on behalf of Noble Energy Inc., that this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for the establishment of fence, building, or other future improvement lines.

Notes:

1) All bearings are Grid Bearings of the Colorado State Plane Coordinate System, North Zone, North American Datum 1983/2011. The lineal dimensions as shown herein are grid distances based upon the "U.S. Survey Foot." To get ground distances multiply shown distance by 1.000238434.

2) Ground elevations are based on an observed GPS elevation (NAVD 1988 DATUM).

3) NEAREST EXISTING WELL IN SECTION 22 IS: SPIKE ST GWS D 22-4J, 383' E

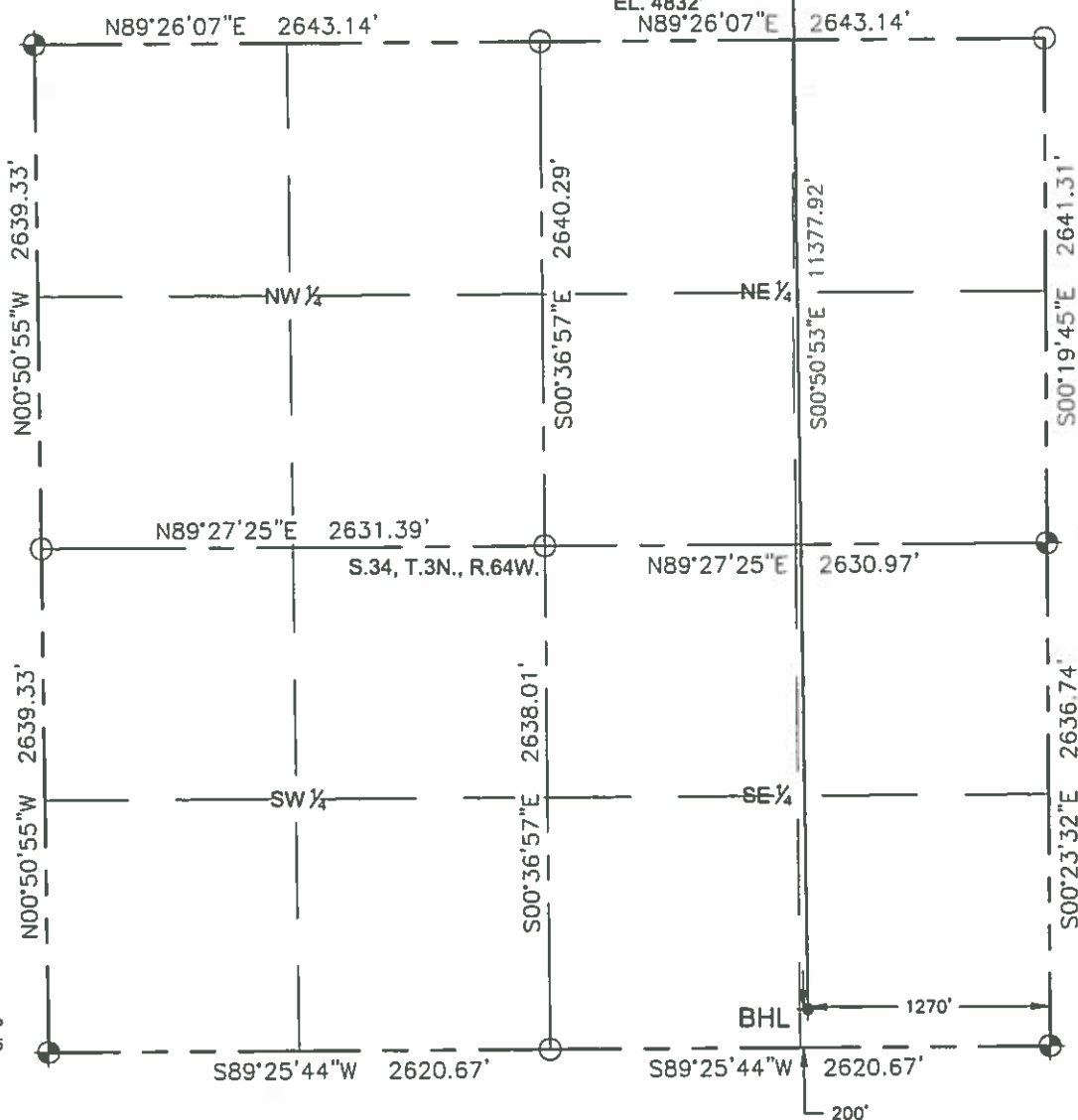
