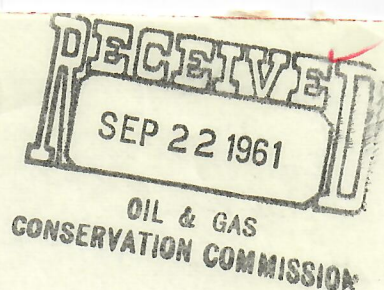

A notice of intention to drill a well shall be filed in duplicate on all Federal and Patent State lands. Do not begin operations until approved copy has been received. It is mandatory that the proposed location comply with all rules and regulations of the Commission. Locate well on section grid in proper location, and indicate extent of lease. Unless operations are commenced within 180 days after the date of approval hereof, this approval to drill will become null and void.

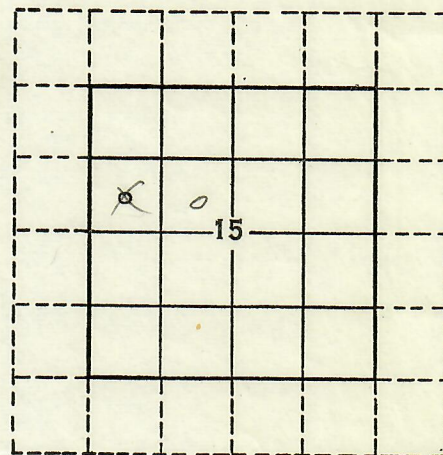

OIL AND GAS SHOWS WILL BE TESTED AT THE TIME OF PENETRATION. AT 5400' WILL RUN 7-5 8" INTERMEDIATE CASING AND DRILL OUT FROM UNDER WITH GAS. WILL DRILL APPROXIMATELY 1000' OF MESA VERDE FORMATION WITH GAS.
