Dear Director Murphy,

Confluence Resources (Confluence) respectfully requests that the Director grant an exception location to Colorado Oil and Gas Conservation Commission (COGCC) Rules 318A.a. for the above referenced well. The surface location, pertaining to the Application for Permit to Drill (APD), does not conform to COGCC Rules 318A.a. due to surface owner request. The proposed surface location was agreed upon by the surface owner after several consultations.

COGCC Rule 318.A.a stipulates that a Greater Wattenberg Area (GWA) well surface location must be within a 400' by 400' drilling window centered at the center of each quarter-quarter section, or inside a 800' by 800' drilling window centered at the center of each quarter section. The above referenced well falls outside of these drilling windows.

Confluence requests the Director approve the proposed exception location. The surface owner acknowledges and agrees with the staked surface location of the well. The Exception Location Waiver is attached.
