<p>Comment: Cobble rundowns and check dams are installed in diversion channel and are largely functioning. However additional stabilization is needed as cobble check dam in diversion is already full of sediment and needing maintenance.</p> <p>Corrective Action: As initial corrective action is addressed, a new corrective action date is applied. Additional stormwater controls and sediment removal/maintenance is needed to control erosion in the northern project area. Seeding or use of other slope stabilization products such as erosion control blankets on the diversion berm and slopes will help provide stabilization, as well as installation of sediment controls where stormwater flows into the project area.</p>						Date: 10/19/2018
