COGCC staff, Chris Binschus, did mention that mowing by itself would not be sufficient. Canada thistle is a persistent perennial weed that will require several seasons of management effort for effective control. Canada thistle reproduces by seed and rhizomes. Operator should consider additional management practices (i.e., applying an herbicide during the Fall and/or Spring).
