Technical Detail/Comments:

QEP received a Field Inspection Form (DOC #682501307) on 09/14/2016. The Corrective Action was to cut off casing that was protruding above ground by about 3 ft and recontour/reclaim location. This well was a dry hole that was plugged on May 05/09/1973 by Chandler and Associates. QEP inherited this well through an acquisition. When QEP cut the casing off 4 ft below surface, we discovered 12 ft of void space. Stephanie Tomkinson, QEP, immediately notified Diana Burn, COGCC, and asked for direction on how to proceed. It was decided that QEP would add cement to the 12 ft of void space, weld on the name plate, and continue with reclamation. This report is to document that 10 ea. 60 lb. sacks of cement were added to the top of this casing to eliminate any void space.

A serperate Form (FIRR) will be submitted to document the reclamation work that was completed.
