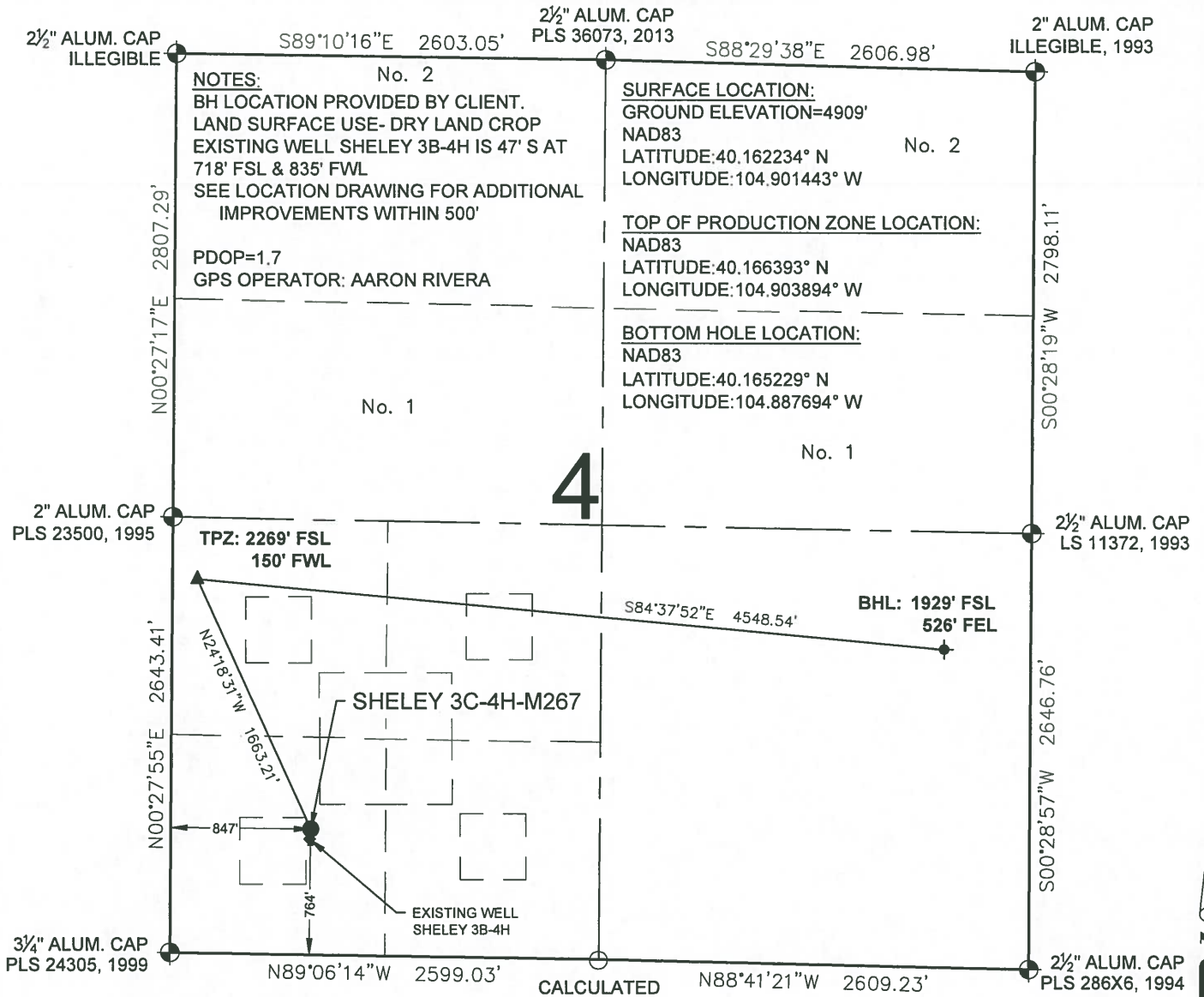


SHELEY 3C-4H-M267 WELL LOCATION EXHIBIT
