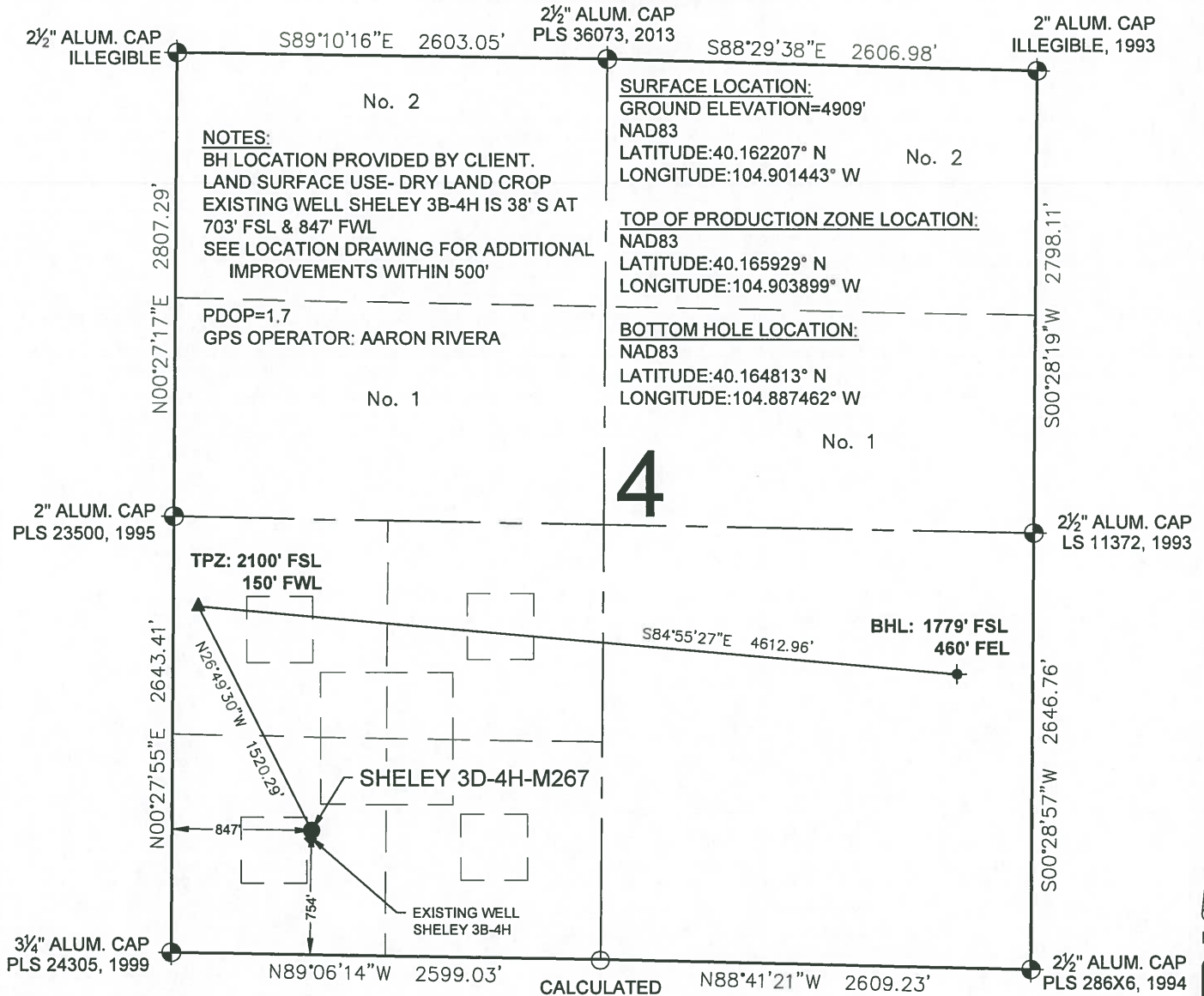


SHELEY 3D-4H-M267 WELL LOCATION EXHIBIT

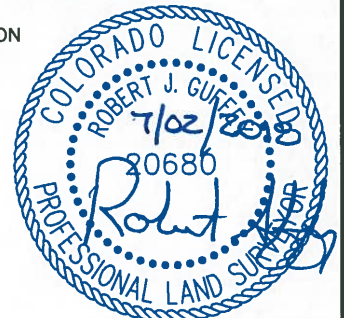
