Crestone Peak Resources Operating LLC (CPR) is planning to drill the above referenced well(s) in accordance with the provisions of COGCC Rule 318A.e(6). CPR's proposed spacing unit configuration consists of:

Township 2 North, Range 67 West
S2 of Section 4
E2SE of Section 5

Containing 400 acres, more or less for the Niobrara and Codell formations

CPR is not the only owner within the proposed spacing unit, and as such provided notice to the remaining owner(s) within said proposed spacing unit as required under COGCC Rule 318A.e(6). The required thirty (30) day notice period has elapsed absent the receipt by CPR of an objection to said proposal by the owner(s) within the Proposed Spacing Unit for the subject well.

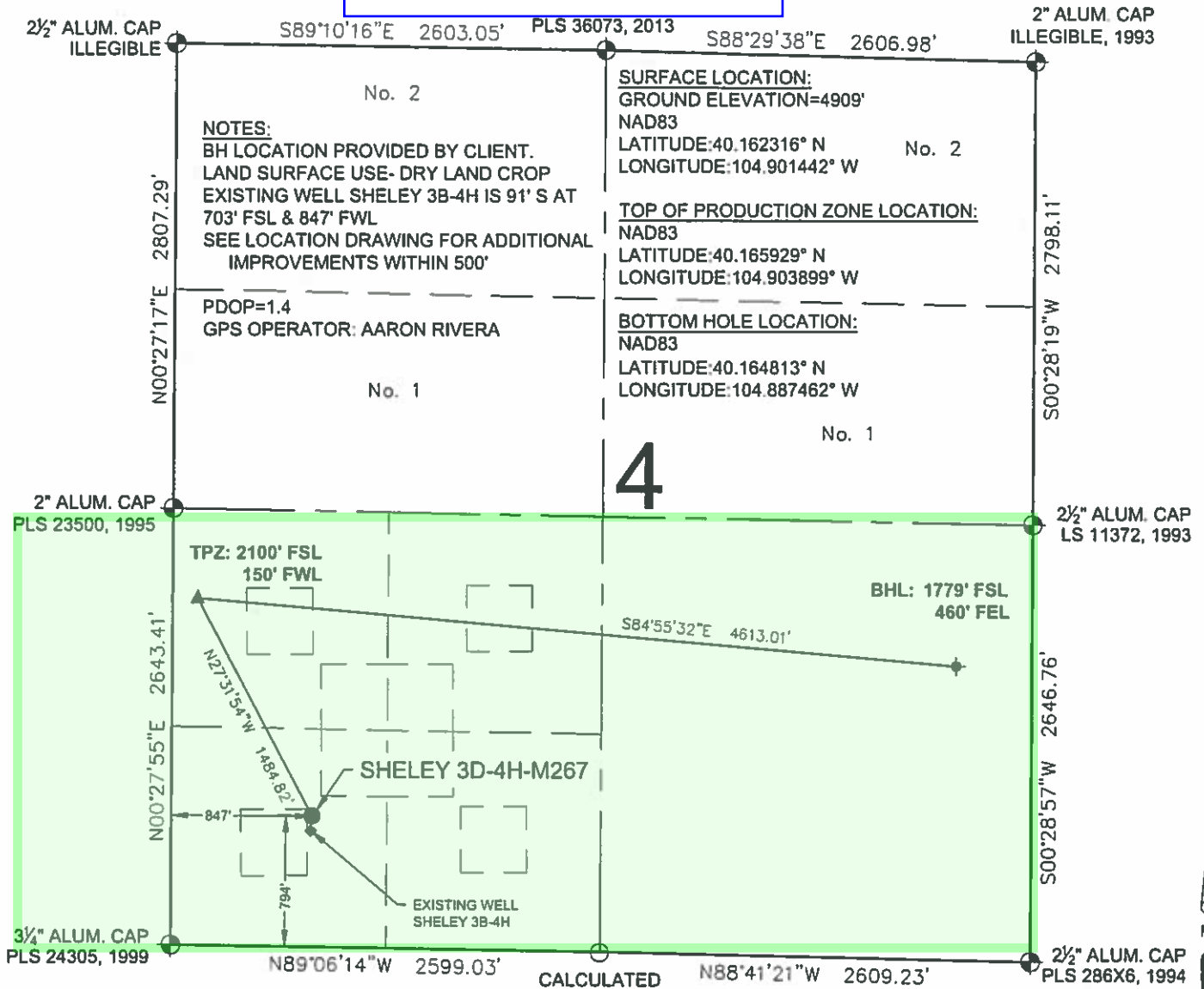

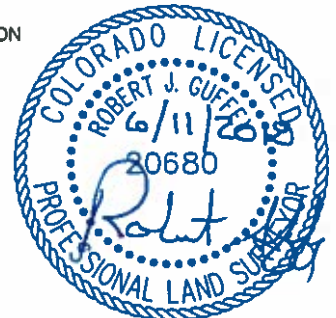
