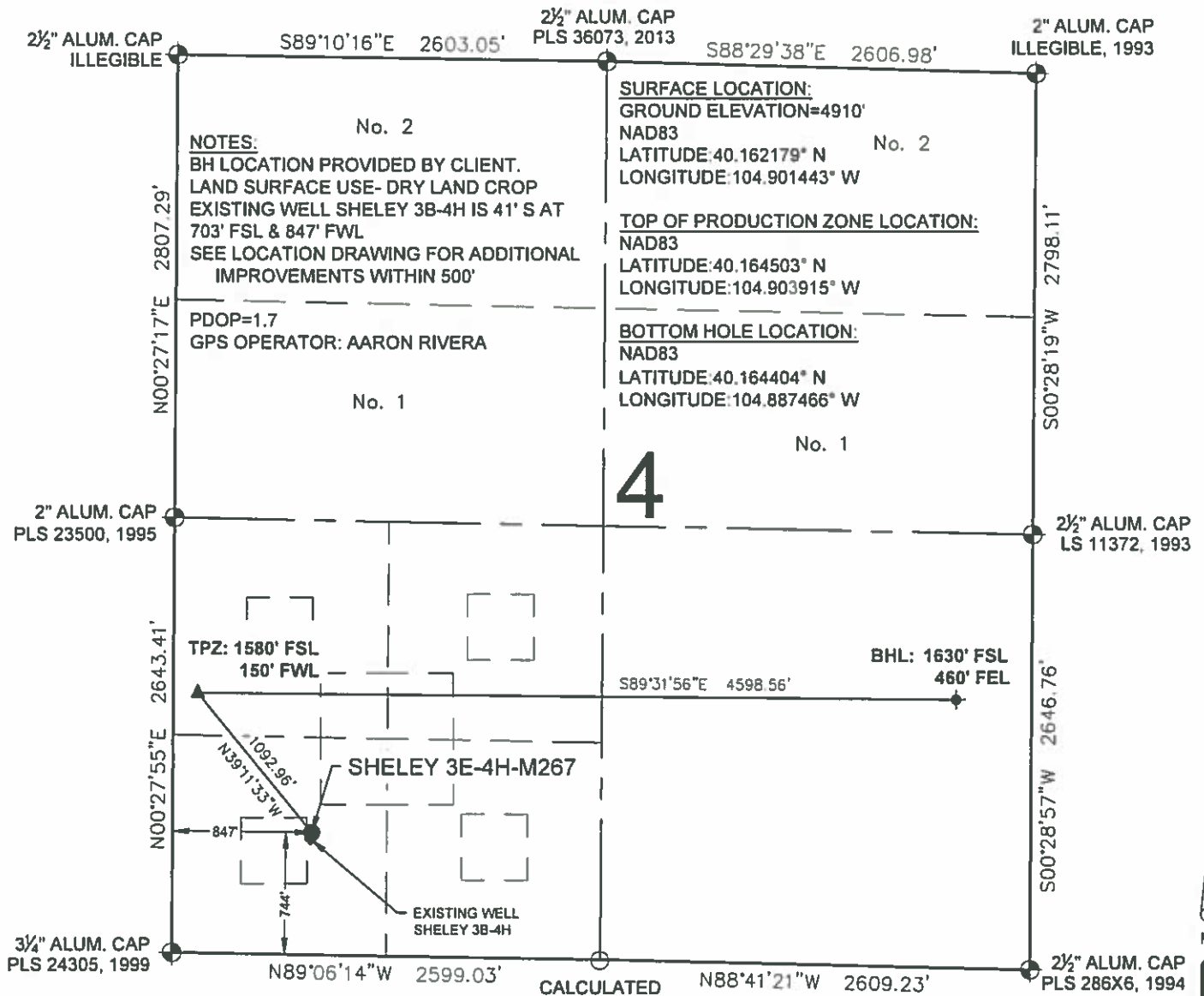


# SHELEY 3E-4H-M267 WELL LOCATION EXHIBIT



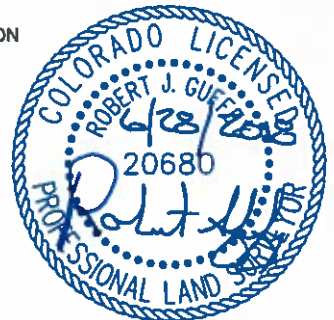
