Comment: List B Colorado noxious weeds (thistles) were observed throughout the entire well location. Mostly Scotch thistle but some Canada thistle was also observed. Operator will likely need to perform long-term weed management, as weed control has not been properly conducted. Noxious weed infestation has grown since the last inspection. Operator shall continue to monitor and manage this site until the Location meets Rule 1004 standards, including weed management. Refer to the attached inspection photos.
